**ALTERNATES:** The following information is how EVRC will handle alternates these three days of Tests and Trials, both sheep and ducks. EVRC will accept a maximum of 8 (eight) alternates test and trial combined. There are 3 Events this three day weekend. In the event limits are reached prior to closing, alternates will be numbered 1 - 8 as they come in. Once entries close, the alternates will be numbered by class. Example: Alternates #2 and #5 are both in the advanced sheep class. They are then renumbered A1 and A2. The trials will start with Advanced sheep and end with Herding Started ducks each day. At the time of closing, there will be a set number of Test and Trial runs. This will not change. If there ends up being a Trial run available with no Trial alternates, the run CANNOT be changed to a Test run. Each alternate will be notified by email that they are on the alternate list and given the opportunity to pull or remain on the list. You need to make sure your email address is readable. Or phone number if you do not have email. A refund will be given, less a \$5.00 fee, if the Secretary is notified prior to the trial start and an alternate takes that run. No alternate, no refund.

If you are an alternate and pull prior to closing or don't have an opportunity to run your check will be returned.

If you are an alternate, and have the opportunity to run and aren't present to run your dog, no refund will be made.

**BITCHES IN SEASON** will run in catalog order in all trial classes, but will be placed at the end of the running order in all test classes.

**ERRORS ON ENTRY FORMS:** Owners are responsible for errors in making out entry forms (whoever may make such errors) and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Please type or print clearly and carefully the information on entry forms to eliminate errors.
